Leaves are allowed as per ICAI Rules. Currently 24 leaves are allowed in 2 year articleship period. Besides office also has around 12-15 holidays every year like for Diwali, Independence Day, Holi, Gudi Padwa and so on.

2. What is the stipend for articles?

We pay a stipend of Rs. 10,000 and 12,000 in first and second year of articleship.

3. What are the office timing?

Office Timing are 10.30 AM to 7 PM - Monday to Saturday.
